**Terms and conditions:**

- 1) Interested Firms / persons may inspect the said vehicle physically on any working days from Monday to Saturday between 03 00 PM to 5.00 PM at the above mentioned office Premises.
- 2) The disposal of vehicles shall be strictly on "AS IS WHERE IS BASIS" and no guarantee of quality or certificate of its worthiness will be given by this office.
- 3) Firms/ Persons who are interested to participate in the auction should deposit an EMD amount of **Rs. 600/- (Rupees Six Hundred only) in the Form of DD /Banker's Cheque only drawn in favour of "The Director, CSRTI, Gobichettipalayam, on or before 10.12.2020 up to 10.30 AM** and obtain proper acknowledgement. The EMD will not be accepted beyond the prescribed date & time. EMD will not bear any interest.
- 4) The bidder has to provide his full Name / Name of the authorized signatory of the Firm/Name of Father. Full Postal Address, Telephone Number and Mobile Number before participation in the auction process.

No parties will be allowed to participate in the public auction without submission of the required EMD

- 5) EMD of the First, Second and Third highest bidders will be retained by this office till the disposal of the vehicles to the successful bidders. The EMD of other unsuccessful bidders will be refunded after completion of the action process.
- 7) The successful bidder should **deposit 25% (Twenty-five Percent) of the bid amount on the spot either by Cash or in the form of DD/Banker's Cheque drawn in favour of "The Director, CSRTI, Gobichettipalayam. The balance amount should be deposited within 3 (Three) working days after completion of the auction in the same form of payment as above.** If he fails to deposit the balance amount within the stipulated time of 3 (Three) working days, the 25% amount so deposited will be forfeited along with the EMD.
- 8) The Successful Bidder should remit 25% of the Bid Value on spot PLUS the GST (i.e) CGST 9% and SGST 9% on the bid amount at the time of depositing.
- 9) The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of his/her/their Residential Status (Ration Card, Voters Identity Card or Aadhar Card etc., in case of individual and Registration Certificate in case of firms etc )
- 10) The disposed vehicle will be removed by the successful bidder within 48 hours of depositing the money at their own expenses. No assistance / transportation will be provided. Permission to take out the disposed vehicle from this office will not be allowed on Holidays & Sundays. The liability towards transportation taxes, etc.. shall rest with the bidder.
- 11) If the highest bidder / highest quoting firm fails to honour the bid, the contract will be cancelled and its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible party to complete the bid provided he is prepared to accept the price offered by the H-1 party. In case of any dispute, decision of CSB shall be final.
- 12) CSB employees should not participate in the auction process.
- 13) **Since the vehicle is declared as scrap, no documents available for transfer. Hence successful bidder is responsible to transport the vehicle by towing / dismantling at his own cost. The office will not be responsible for any lapse on his part in this regard.**
